# **WORK WITH US: PRIVACY POLICY**

#### IN ACCORDANCE WITH ART. 13 REGULATION (EU) 2016/679

In accordance with Art. 13 of Regulation (EU) 2016/679, the company SAPI MED SPA based in Via della Chimica no. 6 - Alessandria, in the capacity of Data Controller, hereby informs users of the website www.sapimed.com, who request information, of the following:

#### DATA PROCESSED

### NATURE OF PROVISION OF DATA

The provision of personal data by users is optional. However, any failure to provide the data may involve the impossibility of being able to follow up on requests sent or which the user intends to send.

## PROCESSING METHODS

The data are processed through IT or electronic methods and on paper by those authorised by the Controller who have been specifically instructed to guarantee respect and protection of the personal data processed.

For storage, the Controller guarantees that it adopts all appropriate security measures as envisaged by the legislation.

#### **DATA STORAGE PERIOD**

The data will be processed for the time strictly necessary to achieve the purposes for which they were collected (processing of requests received).

#### COMMUNICATION AND DISSEMINATION, RECIPIENTS

The personal data will be processed by persons expressly and specifically designated by the Controller in the capacity of Processors or officers.

The data may also be processed by third parties (outsourcers) and consultants, employed to provide services connected to the purposes pursued, in relation to which our organisation assesses each time - in order to guarantee greater protection - whether to appoint them as Processors for the processing implemented by them.

In all cases, those entities will process the data in accordance with instructions received from the Controller, according to the operational profiles attributed to the same based upon the functions performed, limited to what is necessary and instrumental for the execution of specific operations involved in the services requested and exclusively to achieve the purposes indicated in this privacy policy.

The list of Processors, which is constantly updated, may be requested by sending a communication by the methods indicated in the point below concerning the rights of the Data Subject.

The data may also be communicated to public and/or private third parties and competent authorities that are entitled to access the data by virtue of the law.

The data will not be disseminated, sold or exchanged with third parties without the express consent of the Data Subject.

#### TRANSFER OF DATA OUTSIDE THE EU

The data collected will not be transferred outside the European borders.

#### RIGHTS OF THE DATA SUBJECTS

The Data Subjects, to whom the personal data refer, may exercise the following rights at any time:

<u>Art. 7 - Right to</u>	The data subject shall have the right to withdraw his or her consent

	Prior to giving consent, the data subject shall be informed thereof.

Art. 15 - Right of access	The data subject shall have the right to obtain from the controller
	confirmation as to whether or not personal data concerning him or
	her are being processed, and, where that is the case, access to the
	personal data and information regarding the processing.
Art. 16 - Right to	The data subject shall have the right to obtain from the controller
<u>rectification</u>	without undue delay the rectification of inaccurate personal data

	processing, the data subject shall have the right to have incomplete
	personal data completed, including by means of providing a
	supplementary statement.

Art. 17 - Right to erasure (right to be forgotten)	The data subject shall have the right to obtain from the controller the erasure of personal data concerning him or her without undue delay and the controller shall have the obligation to erase personal data without undue delay.
Art. 18 - Right to restriction of processing	The data subject shall have the right to obtain from the controller restriction of processing where one of the following applies:  a) the accuracy of the personal data is contested by the data subject, for a period enabling the controller to verify the accuracy of the personal data;  b) the processing is unlawful and the data subject opposes the erasure of the personal data and requests the restriction of their use instead;  c) the controller no longer needs the personal data for the purposes of the processing, but they are required by the data
	subject for the establishment, exercise or defence of legal claims; d) the data subject has objected to processing pursuant to Article 21(1) pending the verification whether the legitimate grounds of the controller override those of the data subject.
Art. 21 - Right to object	The data subject shall have the right to object, on grounds relating to his or her particular situation, at any time to processing of personal data concerning him or her which is based on point (e) or (f) of Article 6(1), including profiling based on those provisions.
Art. 22 - Right not to be subjected to automated individual decision-making, including profiling	The data subject shall have the right not to be subject to a decision based solely on automated processing, including profiling, which produces legal effects concerning him or her or similarly significantly affects him or her.
Art. 77 - Right to lodge a complaint	Every data subject shall have the right to lodge a complaint with a supervisory authority, if the data subject considers that the processing of personal data relating to him or her infringes the privacy regulation.
